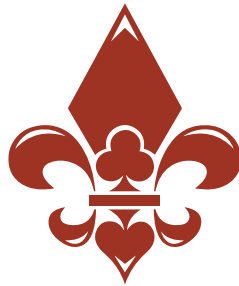

1. Pearl River Poker Room Tournament Rules approved by the Choctaw Gaming Commission apply.
2. There will be 3 (three) Mega Satellites held during the months of October and November on the following dates and times:
 - a. Mega Satellite #1 (one) will be held at 12:00pm (noon) February 7, 2021.
 - b. Mega Satellite #2 (two) will be held at 12:00pm (noon) February 21, 2021.
 - c. Mega Satellite #3 (three) will be held at 12:00pm (noon) March 7, 2021.
3. Registration will begin 2 hours before each scheduled Mega Satellite.
4. The number of entries allowed for each Mega Satellite will be limited to available seating. Pearl River Poker may revise the number of Poker Tables available if the minimum number of participants is not met or the maximum number of participants is exceeded. Alternates and late sign-ups for all events will be allowed to enter during the first four (4) levels. Alternates and late sign-ups may require a new stack of chips. Late sign-ups that require a new stack of chips to be placed on the table will have the equivalent of all blinds and/or antes extracted from the stack for every level of the tournament that has elapsed. Players will be allowed to reenter the tournament as many times as they wish up until the start of Level five (5).
5. Two (2) \$600 seats to Event #8 of the Pearl River Poker Open March 18th-March 28th, 2021 will be guaranteed in these Mega Satellites. These two seats will be funded from the Bad Beat Jackpot Promotional fund account 1-0000-0000-26201. None of the money added from the Jackpot Promotional fund will be subject to any fees or commissions and 100% of the funds will be paid to the players who place in the tournaments.
6. For every \$600 in the prize pool, beyond the \$1200 needed for the guaranteed two seats, one seat to the \$100,000 Guaranteed Main Event (#8) will be awarded in tournament entry receipt.
 - a. The remaining prize pool will be paid to the highest finisher that does not place and receive a seat.
 - b. Entries to the \$100,000 Guaranteed Main Event (#8) tournament are non-transferable, non-assignable, and non-refundable.
7. The Buy-In for this event will be a total of \$100:
 - a. \$80 will be allocated to the Prize Pool.
 - b. \$10 will be withheld for the house entry fee.
 - c. \$10 will be withheld for the tournament dealers and staff.
8. Each entrant will start with \$6,000 in tournament chips.
9. All levels will be 20 minutes in duration.
